IN THE MATTER of an application by **the partnership of Susan Stile and Andrew Stile** pursuant to s127 of the Act for the renewal of the OFF Licence in respect of premises situated at 145 Ross Beach Road, Ross known as the "**Always The Weekend**"

The Application

The partnership of Susan Stile and Andrew Stile applies for the renewal of the OFF Licence in respect of premises situated at 145 Ross Beach Road, Ross known as the "Always the Weekend."

The business is attached to the Ross beach Top 10 Holiday Park operated by the Stiles under their company Parklife Tourism Limited The partnership only offers limited amounts of alcohol to tourist staying at the Holiday Park.

The off-sales are effected from a 'mobile shop' 'permanently' positioned adjacent to the reception area and store.

The current days and hours are **Monday to Sunday 2.00pm to 9.30pm. No changes are sought.**

These hours are within the default national maximum trading hours for OFF licensed premises.

The application was publicly notified on the council website from the **12th of April 2024. No objections were received from members of the public.**

Reasons for the Decision

Neither the Police nor the Medical Officer of Health has raised any matters in opposition.

The inspector reports that the amenity and good order of the area has not been reduced by more than a minor extent.

We agree with the Inspector's submission that the situation is somewhat unique and very low risk due to the low volume of sales.

The applicant offer up a discretionary condition that sales can only be made to paying on-site guests. We see value in that.

For the purposes of this licence the licensed premises is the 'mobile shop' only.

I am satisfied as to the matters to which we must have regard as set out in s.131 of the Act.

I deal with the application on the papers.

DECISION

The District Licensing Committee Chairman, acting pursuant to the Sale and Supply of Alcohol Act 2012, **approves** an application by **Susan Stile and Andrew Stile, trading in Partnership, ("the licensee")**, for the renewal of the OFF Licence in respect of premises situated at 145 Ross Beach Road, Ross known as "**Always the Weekend**" subject to conditions.

We refresh the licence conditions to reflect best practice.

Conditions:

The OFF licence is subject to the conditions listed below:

1. Alcohol may be sold on, or delivered from, the premises for consumption off the premises, or supplied free as a sample for consumption on the premises, only on the following days and hours:

Monday to Sunday from 2.00pm until 9.30pm

2. No alcohol is to be sold on, or delivered from, the premises on Good Friday, Easter Sunday or Christmas Day or before 1.00 pm on Anzac Day;

3. **Alcohol can only be sold to on-site paying guests of the Holiday Park.**
4. While alcohol is being supplied free as a sample, water is to be provided to patrons free of charge at the place where the samples are being supplied,
5. The Licensee must have available for purchase on the premises, at all times when the premises are open for the sale and supply of alcohol, a reasonable range of non-alcoholic and low-alcohol beverages;
6. A properly appointed Certificated, or Acting or Temporary, Manager must be on duty at all times, within the licensed area, when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed in the premises;
7. The Licensee must display:
 - a. At every point of sale, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons;
 - b. At the principal entrance to the premises, so as to be easily read by people immediately outside the premises, a sign stating the ordinary hours of business during which the premises will be open for sale of alcohol;
 - c. A copy of the licence attached to the inside of the premises so as to be easily read by people entering each principal entrance.

The renewal will be for three years from the expiry of the current licence and a replacement licence is to be issued.
