The Application

Bravo Twenty Twenty Limited applies for the renewal and variation of the OFF Licence in respect of premises situated at 42 Main Road, Hari Hari known as the "**Hotel Hari Hari.**"

The business is Hotel operating in the remote township of Hari Hari with a "small bottle store incorporated into the business." They offer food, alcohol and accommodation to the locals, tourists and tour parties.

The current days and hours are **Monday to Sunday 8.00am to 11.00pm. A variation is sought to change the hours to 12.00 noon to 10.00pm.**

These hours are within the default national maximum trading hours for OFF licensed premises.

The application was publicly notified on the council website from the 13th of February 2025. No objections were received from members of the public.

Reasons for the Decision

Neither the Police nor the Medical Officer of Health has raised any matters in opposition, but they do note that there is only one certificated manager appointed to the business.

The inspector reports that the amenity and good order of the area has not been reduced by more than a minor extent.

The bottle store is within the Supervised Area of the hotel.

I am satisfied as to the matters to which we must have regard as set out in s.120 and 131 of the Act.

The variation to the hours is a sensible move and will be approved.

I deal with the application on the papers.

DECISION

The District Licensing Committee Chairman, acting pursuant to the Sale and Supply of Alcohol Act 2012, **approves** an application by **Bravo Twenty Twenty Limited** for the renewal and variation of the OFF Licence in respect of premises situated at 42 Main Road, Hari Hari known as the “**Hotel Hari Hari**” subject to conditions.

We also refresh the licence conditions to reflect best practice.

Conditions:

The OFF licence is subject to the conditions listed below:

1. Alcohol may be sold on, or delivered from, the premises for consumption off the premises, or supplied free as a sample for consumption on the premises, only on the following days and hours:

Monday to Sunday from 12:00 noon until 10:00pm

2. No alcohol is to be sold on, or delivered from, the premises on Good Friday, Easter Sunday or Christmas Day or before 1.00 pm on Anzac Day;
 3. While alcohol is being supplied free as a sample, water is to be provided to patrons free of charge at the place where the samples are being supplied,
 4. The ‘bottle store’ is designated as a **Supervised Area**;

5. The Licensee must have available for purchase on the premises, at all times when the premises are open for the sale and supply of alcohol, a reasonable range of non-alcoholic and low-alcohol beverages;
6. A properly appointed Certificated, or Acting or Temporary, Manager must be on duty at all times, within the licensed area, when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed in the premises;
7. The Licensee must display:
 - a. At every point of sale, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons;
 - b. At the principal entrance to the premises, so as to be easily read by people immediately outside the premises, a sign stating the ordinary hours of business during which the premises will be open for sale of alcohol;
 - c. A copy of the licence attached to the inside of the premises so as to be easily read by people entering each principal entrance.

The renewal will be for three years from the expiry of the current licence and a replacement licence is to be issued.
