The Chief Executive (CE) updated the Committee and advised that the CE of Destination Westland (DW) was in favour of doing an audit of historic and current consents and will be taking this to the Destination Westland Board for approval. WDC has offered to support this process and follow up with DW. The aim is to make sure nothing has been missed during the consenting process.

Cr Davidson noted a conflict of interest as a commercial property owner on Revell Street and abstained from voting.

URGENT MATTER ADDED: SEAWALL ERROSION

The Chair advised that the urgent matter was to be considered under the Local Government Act section 46a as the erosion was a risk to property.

His Worship the Mayor spoke to the continued erosion of the Hokitika Seawall from the Beachfront Hotel down to Spencer Street, he noted the rough seas had caused additional erosion in a number of places that had resulted in the sand dune been 3 metres in width in a number of areas and was now threaten ratepayer properties.

Moved His Worship the Mayor, seconded Cr Davidson and **Resolved** that the Chief Executive write another letter to the West Coast Regional Council (WCRC) regarding the urgency of work required to the seawall.
