## Official information request for building and resource consent information for the past 5 years

I refer to your official information request dated 02 August 2023 for building and resource consent information for the past 5 years.

You have asked for the following information:

## **Resource Consents**

1. How many Resource Consents are processed annually over the last five years?

2. What is the average timeframe from original submission to completion for a Resource Consent application to be processed?

The average working day is 10 - 20, excluding hold for further information request or notification.

- 3. What challenges are Council facing in the smooth processing of Resource Consents? (i.e. what could submitters be doing to make it easier to process, or are there other barriers?)
  - Quality of information provided by applicants. For example, thorough planning assessments in respect to the proposed Te Tai o Poutini Plan and assessment of environmental effects.
  - Transparency of intentions, for example, confirmation of the extent of an activity inclusive of all components such as vehicle movements, signage, infrastructure intentions etc. Activities are being undertaken in part or in full prior to permissions being received, resulting in the requirement for remedial works, changes in plans and reassessment under the relevant legislation.

- 6. What challenges are Council facing in the smooth processing of Building Consents? (i.e. what could submitters be doing to make it easier to process, or are there other barriers?)
  - The quality of applications coming through are often incomplete. Even trained professional designers/architects have multiple RFIs due to lack of relevant information, not having up-to-date building code compliance pathways, and very basic information such as owner details and site/ground reports are incorrect or missing entirely. Owner applications done by non-professionals are similar, with details and information missing.
  - The online consenting system is overwhelming for first-time users with little experience. Help is available with tutorials online, some prefer not to watch these and struggle as a consequence.

## 7. Is there any other information or data that you think is relevant to building and resource consents and increasing the housing supply across Te Tai o Poutini?

Yes – the number of consents for new dwellings is much smaller than the number of building consents issued.

- Over this time only 3 consents for a MBIE Multiproof dwellings have been issued.
- Over this time only 6 consents for residential multi-unit (more than two dwellings) have been issued.
