2. WORKSHOP ITEMS

The Acting Group Manager District Assets and the Asset Strategy and Development Manager introduced the Powerpoint and advised the purpose of the workshop as follows:

- To review Council's obligations.
- To review the proposed enforcement options.
- Consultant Question and Answer Session.
- To discuss and agree on restricted and prohibited areas.

The Freedom Camping Act 2011 permits freedom camping in any local authority area unless it is restricted or prohibited by a local bylaw or any other enactment.

The Act does not recognise that some areas under the control or management of Council may not be suitable for freedom camping.

A bylaw can identify where freedom camping is prohibited and restricted.

In accordance with the Act, areas may only be prohibited or restricted for the following reasons:

- 1. To protect the area.
- 2. To protect the health and safety of people who may visit the area.
- 3. To protect access to the area.

All areas must be assessed against the three criteria before any restrictions or prohibitions are applied to ensure the bylaw is appropriate, proportionate, consistent and defensible.

As part of the bylaw-making process, there is a one-month consultation via a special consultative procedure where organisations and people can submit on the proposal.

From 7 June 2025, there will be changes in the self-containment rules, which will mean that all vehicles will need to be certified with a green warrant to be certified self-contained under the new requirements.

Council staff have used the Local Government New Zealand Freedom Camping Bylaw and Guidance to create the proposed bylaw.

Freedom Camping Statistics were provided, each camper on average spends \$150.00 per day, and they travel across multiple districts.

Enforcement Options including the cost, positives and negatives were provided.

Sam Strong, Recreation and Open Spaces Planner, and Geoff Canham, Principal Parks and Recreation Specialist from Thrive Spaces and Places attended the meeting to talk about what other Councils are doing in their district, how freedom camping friendly they have made their district, and the key things that Council needs to think about in making a bylaw and answer any questions that Councillors may have. Thrive Spaces and Places is a specialist parks and recreation consultancy focusing on strategic and management solutions, project and programme management, planning, assessments and evidence work for agencies and communities.

Topics discussed included who the campers are, the spectrum of tourists that come to Westland, types of vehicles freedom campers are driving, and by not having a bylaw that facilitates some agreeance to some freedom camping, campers can camp within 200 metres of any accessway, roadway or riverway, if they are self-contained.

The Asset Strategy and Development Manager then talked about the site assessments that had been undertaken. Council staff undertook a desktop assessment of all Council-owned reserves, community halls and public toilet sites, as well as previously known freedom camping sites. As a result of the shortlist selected sites were then selected to undertake a field assessment.

Key considerations were then discussed.
