Official information request for information on local measures to protect penguins

I refer to your official information request dated 15 October 2024 for information on local measures to protect penguins.

You have asked for the following information:

- Details of rules/policies/objectives in your district plan designed to avoid adverse effects of dog attacks and vehicle strike on penguins (specifically hoiho and kororā).

- 2. Decision making materials that underpin the making of the district plan (including any plan changes) where the need to give effect to the New Zealand Coastal Policy Statement (NZCPS) was considered.

The NZCPS has informed the Te Tai o Poutini proposed combined district plan for the West Coast. Relevant chapters include Public Access — Te Āheinga Tūmatanui and CE Coastal Environment — Te Taiao o te Takutai. The operative Wetland District Plan dates from 2002 and predates the NZCPS.

3. Details of any bylaws or other local measures that protect penguins from dog attacks or vehicle strike.
