Dear Private Individual

Official information request for food premises within the Westland District with consent/approval to discharge trade waste into the council sewerage infrastructure.

I refer to your official information request dated 04 January 2025 for food premises within the Westland District with consent/approval to discharge trade waste into the council sewerage infrastructure.

Food preparation businesses are not permitted to discharge waste (grease, fats, oil etc). As part of the building consent process, they are required to have a grease/fat interceptor or trap. These traps/interceptors are not permitted to discharge into the Westland District sewage infrastructure.

Below is the list of licenced food premises, that under the Building Act would require a grease/fat interceptor or septic tank.
