IN THE MATTER of the Sale and Supply of Alcohol Act 2012 (the Act)

IN THE MATTER

of an application by Destination Westland Limited pursuant to s138 of the Act for an on-site Special Licence in respect of premises situated at Cass Square, Hokitika known as the "Wildfoods Festival."

BEFORE THE WESTLAND DISTRICT LICENSING COMMITTEE

THE APPLICATION

Destination Westland Limited applies for an on-site Special Licence in respect of premises situated at Cass Square, Hokitika known as the **"Hokitika Wildfoods Festival.**"

The licence is to support the annual Wildfoods Festival in the Square. It is estimated that up to 10,000 people will attend the event.

Substantive food and low alcohol and non-alcoholic beverages will be available at all times from various stalls and certificated managers will oversee the sale, supply and consumption of alcohol.

Twenty-eight security officers will also be engaged on entry and perimeter control.

A comprehensive Alcohol management Plan has been provided for this event.

The day and hours sought are:

Saturday 8 March 2025

10.00am to 7.00pm

THE REASONS FOR THE DECISON

The Inspector has provided a report on the application and believes the application meets the criteria for issue.

Experienced certificated managers will be overseeing the sale, supply and consumption of alcohol.

The Police do not oppose but recommend hourly meetings from 12.00 noon with the applicant and any agencies present as the day progress. We agree with this suggestion, and it will be imposed.

The report of the delegated officer for the Medical Officer of Health carries matters in opposition that have not been resolved days out from the event.

Pragmatically, both Mr. Beckett, and the applicant, have invited the DLC to determine the appropriate service size for the event. We thank the parties for entrusting the DLC to make the decision short of holding a hearing.

An AMP has been produced and there will be limits on alcohol service size during the day and a One Way Door (OWD) will apply at this year's event.

OWDs are a valuable tool, and they prevent patrons exiting the venue and side loading alcohol before returning to the venue. This will not be possible this year.

Comprehensive wrist banding will be undertaking to ensure there will not be a repeat failed CPO as occurred at the 2023 festival. Measures have been put in place and there must be no repeat failures.

The DLC chair is familiar with effective service regimes employed at other large concerts and events around NZ.

Maximum service size is to be 4 drinks per person from the Main Bar Tent and two from the other bars.

At **5.30pm** service sizes are to drop to 2 from the main bar and 1 from the other bars.

All bars are to cease the sale of alcohol from 6.30pm.

There is to be hourly meetings from 12.00 noon between the applicant and the agencies present.

Upon request from the agencies the service size regime may be lowered further if deemed necessary to manage rising intoxication levels. The request must be evidence based.

Overall, I am satisfied as to the matters to which we must have regard as set out in s.142 of the Act.

DECISION

The District Licensing Committee, pursuant to the Sale and Supply of Alcohol Act 2012 **grants** the application by **Destination Westland Limited** for an on-site Special Licence in respect of premises situated at Cass Square, Hokitika known as the **"Hokitika Wildfoods Festival**" subject to conditions.

Conditions:

The licence is subject to the following conditions:

1. Alcohol may be sold and supplied for consumption on the premises only on the following days and hours:

Saturday 8 March 2025 10.00am to 7.00pm; bars to close at 6.30pm to allow for the orderly drink up and dispersal of patrons.

- 2. Drinking water is to be provided to patrons free of charge from a water supply prominently situated on the premises.
- 3. A certificated manager must be on duty at all times when the premises are open for the sale and supply of alcohol;
- 4. Food must be available for consumption on the premises at all times the premises are open for the sale and supply of alcohol, in accordance with the sample menu supplied with the application for this licence or menu variations of a similar range and standard.

- 5. The licensee must have available for consumption on the premises, at all times when the premises are open for the sale and supply of alcohol, a reasonable range of non-alcoholic beverages.
- 6. The Licensee must display signage as follows:
 - a) At every point-of-sale detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons;
 - b) A copy of the licence attached to the premises so as to be easily read by persons attending the premises; and
 - c) A sign prominently displayed at the premises, which identifies by name the manager for the time being on duty.
- 7. The licensee must provide information and advice about forms of transport available to patrons from the licensed premises.
- 8. No BYO alcohol is permitted to be brought into the venue.
- 9. All drinks are to be supplied in cans or plastic cups.
- 10. Maximum service size is to be 4 drinks per person from the Main Bar Tent and two from the other bars.
- 11. At 5.30pm service sizes are to drop to 2 from the Main Bar and 1 from the other bars.
- 12. The Alcohol Management Plan provided shall be followed at all times.
