### **THE APPLICATION**

Hokitika Golf Club Incorporated applies for an on-site Special Licence in respect of premises situated at 206 Golf Links Road, Hokitika known as the "Hokitika Golf Club."

The licence is to host two corporate gold days over the next couple of weeks. It is estimated that up to 40 persons will attend the occasions.

Substantive food, low alcohol and non-alcoholic beverages will be always available, and a certificated manager will oversee the sale, supply and consumption of alcohol.

The days and hours sought are:

Friday 14 February 2025 12.00 noon to 7.00pm. Friday 21 February 2025 12.00 noon to 7.00pm

### THE REASONS FOR THE DECISON

The Inspector has provided a report on the application and believes the application meets the criteria for issue.

Experienced certificated managers will be overseeing the sale, supply and consumption of alcohol.

Neither the reports of the Police, nor that of the Medical Officer of Health, raises any matters in opposition.

I am satisfied as to the matters to which we must have regard as set out in s.142 of the Act.

#### **DECISION**

The District Licensing Committee, pursuant to the Sale and Supply of Alcohol Act 2012 **grants** the application by the **Hokitika Golf Club Incorporated** for an onsite Special Licence in respect of premises situated at 206 Golf Links Road, Hokitika known as the "**Hokitika Golf Club**" subject to conditions.

# **Conditions:**

The licence is subject to the following conditions:

**1.** Alcohol may be sold and supplied for consumption on the premises only on the following days and hours:

Friday 14 February 2025 12.00 noon to 7.00pm. Friday 21 February 2025 12.00 noon to 7.00pm;

- 2. Drinking water is to be provided to patrons free of charge from a water supply prominently situated on the premises.
- 3. A certificated manager must be on duty at all times when the premises are open for the sale and supply of alcohol;
- 4. Food must be available for consumption on the premises at all times the premises are open for the sale and supply of alcohol, in accordance with the sample menu supplied with the application for this licence or menu variations of a similar range and standard.
- 5. The licensee must have available for consumption on the premises, at all times when the premises are open for the sale and supply of alcohol, a reasonable range of non-alcoholic beverages.

- 6. The Licensee must display signage as follows:
  - a) At every point-of-sale detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons;
  - b) A copy of the licence attached to the premises so as to be easily read by persons attending the premises; and
  - c) A sign prominently displayed at the premises, which identifies by name the manager for the time being on duty.
- 7. The licensee must provide information and advice about alternative forms of transport available to patrons from the licensed premises.
- 8. No BYO alcohol is permitted to be brought in to the Club
