Section 2: Need for Funding

2.1 Describe how your area/community is impacted by Freedom Camping?

Introduction

The West Coast is seen by many as being the jewel in the crown, the untouched, untamed paradise, having spectacular visa of the Southern Alps, Mt Aoraki, Fianz Josef and Fox Glaciers along with an abundance of pristine lakes to visit and camp. The majority of the land is covered in ancient podocarp forest drawing large numbers of both local and international visitors whom on average stay longer due to the low cost of camping and natural beauty of the area. Geographically the West Coast extends some 650km from Cahurangi Point in the north to Big Bay in the south, approximately 2.3 million hectares or land being administered by three District Councils. Westland makes up the majority of the area with its rate base of around 8,600 people spread throughout the district in small provincial towns and farming areas. Tourism is a major contributor to the West Coast economy (67% of the districts GDP) having drawn up to 17,000 campers per night (Fig1) in the peak of last season.

Covid impacted heavily on some parts of the Coas' with many business whom traditionally relied on international tourism for example, Franzi or ef and Fox Glacier saw a significant downturn, while other areas remaining buoyant the pandemic due to domestic travel. In both cases freedom camping remained popular and without additional funding Westland struggled to meet the demands related to both compliance and advocacy. With the return of International visitors it is expected that Westland will return to pre Covid conditions.

The below table provides a breakdown of visitor type, both international and domestic that have used Westland freedom camping sites. Also the seasonality showing that overnight visitor stays in Westland remains consistent at 2 nights on average throughout the year.



This last season (2021-22) freedom camping in a ighout the Westland region maintained on average 1416 overnight stays per month, despite Covid. 57.5% of those visitors recorded travelling with more than one person in the rehicle. The above graph also illustrates that Westland attracts both domestic and international visitors not just for the tourist season but for the full year. The current funding in odel does not recognise compliance cost that fall outside of the freedom camping season with any short fall burdening the rate payer.

Westland District Council initiatives.

Working alongside pricate businesses, a number of private sites were set up providing free overnight camping for nyi-complying vehicles, those vehicles that did not meet the accepted NZ standard for self-containment. Previously the only land available for camping were roadside areas set up on Council and NZTA road reserve land. This proved to be problematic viheraby Council received a ground swell of complaints which ultimately lead to the forced closure of several sites.

Not after what our entire nation has been through with the Ministry of Health pushing hygiene and social distancing with utmost importance.

The freedom camping site at the salmon farm is closed, the compliance officers control to have finished, and here we go, straight back to square one. The majority down this way do not want and never did want freedom campers here. Our Nation has made an unprecedented sacrifice, many of us have zero income right now and this is fully taking the pis.

We need to move forwards, not backwards, What can we do please?

In response Westland District Council trialled a new initiative where not complaint vehicles could camp, free of charge on private land. These campsites adjoined accal business being strategically spread throughout the district to ensure compliance with the responsible camping Initiatives and bylaw. These sites were supported by Council both in terms of waste management and compliance with ambassadors referring non-compliant vehicles to these sites in favour of infringement. These sites had proven popular both in terms of support for local business, but also solved the wider issue of unsightly campers who traditionally draw complaint for camping by the roadside and access ways. Previously MBIE funding was used to fully fund facilities on these sites covering waste management as well as providing online information.

One of the example of a private site "West Coa t netop Walkway" shown below.



This initial i/e saw a clear reduction in enforcement with infringement notices dropping significantly year on year as freedom camping was supported and welcomed. This enabled clear shift from enforcement to an ambassadorial role with visitors reporting via social meua that they felt safe and welcomed on the West Coast.

Dear Sir/Madam,

The Treetop Walkway and Café' is a tourist attraction about 15km south of Hokitik of state Highway 73. The business owns a steel elevated walking structure allowing easy access for patrons to view the large podocarp forest while walking amongst the top blanched about 20m above the ground. Included on site is a café offering coffee and food which have proven popular for those using the freedom camping site.

The business has been operating for nearly ten years. The main focks was the tourist market, both international and domestic with the hope that the are a viculd become more of a destination than a night stay on the way to the Glaciers.

It was a common problem that historically Hokitika was seen as an overnight stay somewhere to buy a piece of Greenstone, purchase a meal and a bed were the only benefit gained. Very few people really went off the beaten track as hey were not aware of the other attractions in the area, of which there are plenty.

In early 2019 I was approached by Westland District Council staff about the possibility to have a freedom camping site on our land. After single discussion with the business owners it was decided to agree with the installation of a site. We were concerned that there would be some negative feedback from local people but decided to go ahead. We felt that the freedom campers would still come and camp in the bush, so we saw the sense in the Councils proposal to have toilets and an area for them to stop.

The site was cleared and the toilets installed. When opened we noticed an immediate use of the site. There were obvious ben if is lirectly from the freedom camping site as regularly campers would come into the cafe for meals and some would walk the track.

The other benefit was it became clear that campers used camping apps on their phones. More and more vistors where coming to the area using the information from the various apps. This continued through the COVID pandemic.

During the pandemic New Zealanders began to travel their own country due to international travel restrictions these people were often in larger campers they had purchased and they would use the amping apps which showed our business as a destination not to be missed.

As a result the Teetop Walkway attractions are now seen as one of the best known attractions in Hokitika area and I believe the Hokitika area has become a destination rather than a stopol on the way south.

The benefits to our business are clear:

Visitor numbers have increased 40%

The freedom camping site was put in by council with all costs of cleaning, severage and rubbish disposal all covered. I ask that the campsite remain in place, we are accepting or the changes forced on Council due to a lack of funding from central government. If the site continues as it is, we are prepared to fund the cleaning as long as it continues to be supported through Council compliance staff as we believe the site is a benefit to our business as well as the uses.

Summary.

The West Coast is a tourist desimation and geographically extends the distance from Auckland to Wellington. Freedom Camping is enshrined in legislation and protected by the Bill of Rights. This affords any person the right to access all parts of Coast. The West Coast draws millions of international and local visitors with a large percentage taking advantage of the ability to camp by oristine waterway, lakes and mountains. With this brings the known issues around waste man gement and environmental impact. Also the misconception of budget camping assen along the road sides and access tracks.

The "MBIE Responsible Camping Initiatives 2020-21" saw a reduction in funding which essentially limited our ability to provide additional private sites, those that would further mitigate the issues associated with non-compliant campers. At the time five private partnership, izedom camping sites where operating. Geographically up to nine sites would have beer ideal. This amount would have allowed suitable travel times and numbers to enter and exit each site.

The following year all funding ceased leaving local government struggling to meet their oligations. This lead to a large number of complaints as Council where unable to provide



the staffing and resource to fulfil their legal obligations under the Freedom Camping Act. By resolution of Council all public sites were closed so as not to further burden the ratepayer. Only local Council Staff warranted to enforce the Act were deployed, with any effect being limited to the Hokitika area.

To date with financial assistance, Westland has managed to strike the right balance, inis being the right of an individual to freedom camp and the protection of the environment. Without suitable funding concern has been raised that we will default to the issue of the past. This application seeks to obtain suitable funding to support our current initiatives and partnerships within the current funding criteria. By continued funding we can provide the necessary capable guardian through our ambassador/ enforcement practices including supporting a welcoming message through our online information system.

- wanting/needing to develop a bylaw or renewed existing one?
- why you need support in addition to your current resources?

Introduction

Having a low rate base, the West Coast is susceptible to changing costs. With any policy change, there is financial impact that is imposed on the ratepayer. This year there have been a number of national policies such as Three Water reform, Combined District Plan that have significantly impacted the West Coast ratepaye. The proposed changes to the Freedom Camping Act and regulations will trigger both the required consultation process and amendment to the current Bylaw. The court of which is unsupported by Council and is not included in the approved Long Term Plan.

Background

The current bylaw was enacted in 2018 after a legal challenge from the New Zealand Motor Caravan Association for et. Westland District Council to accept and adopt the Self-Containment Standard which was previously excluded. The current Bylaw only restricts freedom camping for non-compliant vehicles, those vehicles that don't display a current NZS 5465:2001 certification. The only other restriction of full access to all parts of Westland are certain locations that need to be protected or pose a safety risk as defined under section 11(2) of the Act

In 2020 Westland District Council provided a written submission to central Government outlining the inconsistences in the current self- containment standard along with a number of issues in lar around the use of statutory declarations by rental agencies. This prompted further legal debate in which Westland District Council was directly involved.

With the proposed changes in legislation it will be mandatory for Westland District Council to have the current bylaw reviewed in which a full public consultation will be required. This will include full public engagement with all local communities throughout Westland including lwi. This process will require the preparation of consultation documents, public meetings and hearings, review committee documentation, redraft of the bylaw and submissions of papers for adoption by council. It will also be necessary to have a dedicated community spokesperson employed for the duration of the process. The Westland District Council Freedom Camping Control Bylaw expires within this funding round.
